### **BOOKING PROCEDURE / DEPOSIT.**

To make a reservation, please complete the booking form.

- This form must include a deposit of 25% of the total trip cost. [\$1,400 ]
- A booking is accepted subject to the receipt of written confirmation from us.
  - Payment of final balance is due 60 days prior to departure.
- If a booking is made within the 60 days prior to departure, full payment must  
accompany the booking.

### **INSURANCE.**

It is a condition of booking that you have adequate health & accident insurance\* for  
the full duration of the tour. It is advisable that you also insure expensive camera or  
other equipment separately. We strongly recommend that insurance be purchased at  
the time you pay your trip deposit. Whilst the company does have a Public Liability  
policy, **it is your responsibility to secure your own insurance.**

### **CANCELLATIONS AND REFUNDS.**

If it is necessary to cancel your trip, you should notify us immediately.

I hereby release the company from all such claims, and indemnify the company against all such claims made by or on behalf of any other person.
